The last four days of July were busy in Williamsburg and Jamestown. Hundreds of Jamestowne Society members gathered to celebrate the 400th anniversary of the first meeting of the Virginia General Assembly. This meeting was in place of the more usual May one.

I am active in a number of lineage societies and the national presiding officer of two. I joined

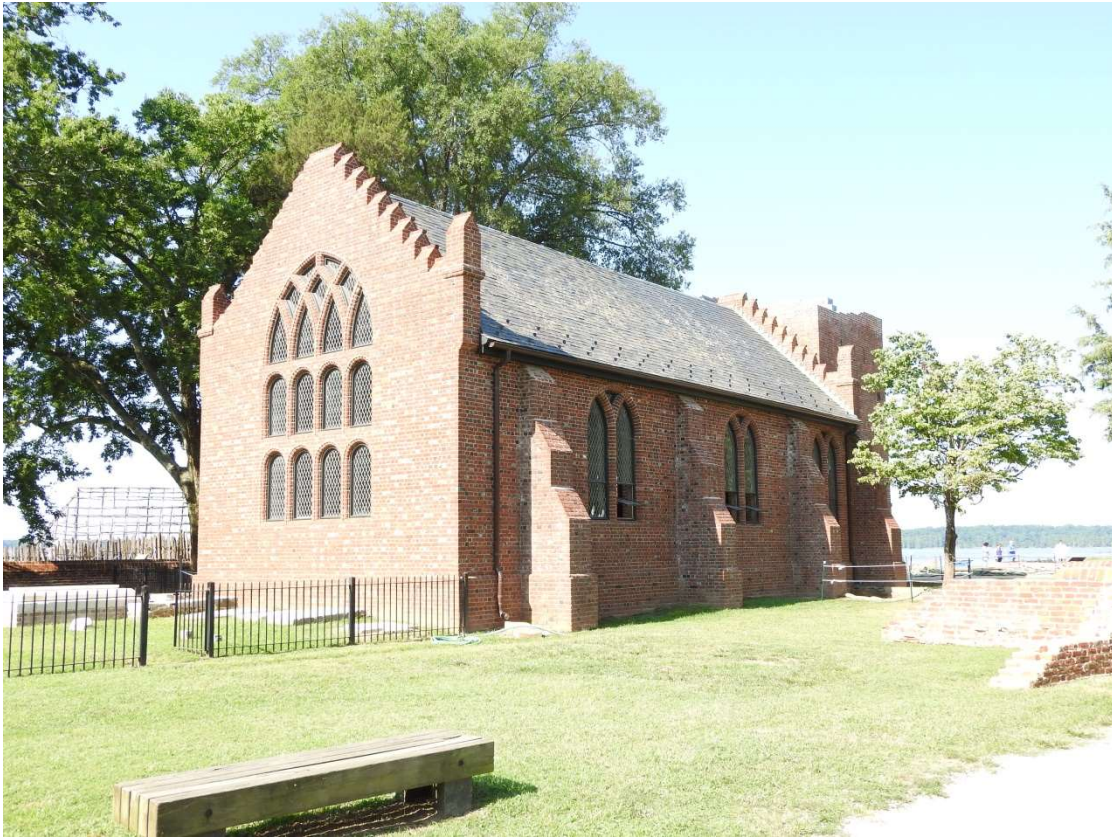
