We want to continue First Maryland Company's maturity and growth. To that end, we've established the following modest goals for 2019—

- ✓ Use electronic communications as our preferred means of sharing information within the Company;
- ✓ Conduct programs that meet members' interests;
- ✓ Expand member involvement in company activities (build or strengthen the "core" mentioned earlier) so that we may expand the Company's elected leadership no later than our 2021 elections; and
- ✓ Increase the company's membership.

In our first newsletter in 2020 we'll assess our first year's performance against these goals. Until then, let's get to know (or better know) one another, discover things about our Jamestowne ancestors, and also have some fun.

Governor's Corner

In addition to the broader Company goals your Council has set, I've set one goal purely for myself. It is—

"To get to know most (hopefully all) of you personally by the end of this year.

Please come to meetings when we schedule them, because I can't meet that goal if you aren't there!!

There's an irony to my being Governor of First Maryland Company. My Jamestowne ancestor is Colonel William Claiborne. An earlier Company governor, Jacque-Lynne Schulman, spoke about him at one of our early Company meetings.

In 1628 he discovered and subsequently named and settled Kent Island. He had a thriving settlement and trading post on Kent Island when, in 1632, King Charles I granted the charter for the new Maryland Colony. That charter included Kent Island in land belonging to Maryland. To say that led to friction would be understatement,! However, I'll leto our May speaker explain how the King's decision led to a rough patch in Virginia-Maryland relations that only ended with Colonel Claiborne's death in 1677. I'm looking forward to our May 14th meeting, and hope you are too!

The Kent Island connection is one example of Jamestowne -Maryland relationships. Doesn't it make you curious about other stories about how the two colonies got along? Or didn't get along? I hope First Maryland Company will explore this theme in 2019 and 2020. But I'd also like to know what themes or subjects **you** might like to explore.
