ASSESSING 2019

The February 28, 2019 Company Newsletter described our company, discussed its past activities, and set goals for 2019 and beyond. A year has passed. How did we do?

Some things have changed very little. For instance, our membership remains geographically dispersed. Although a year older, we still are a relatively new company, and we're still developing a core of seasoned "doers." As this is written, Company membership has declined, but most of the reduction is attributable to four Jamestowne Society members who live far from Maryland, have never attended a Company activity, and have not renewed their Company membership this year.

We held two Company meetings in 2019. More than 20 members and guests attended each meeting, and the two programs were well received. We held our meetings in different parts of Maryland in part to "spread the burden" of driving a great distance to the venue.

Some things have improved. For example, we are vastly more able to communicate with all members electronically, (Thank you for sharing your e-mail addresses with us.) And we've doubled the number of elected Company officers, adding a Secretary of State, a Chaplain, and one Councilor.

Our February 28, 2019 newsletter also contained four goals for the Company, and a promise that we would report one year later on how we did, Here's that report. We hope you agree with our assessment.
